GENERAL INSTRUCTIONS FOR PAPERS PREPARE

- British English is required.
- Page settings:
 - o A4 format,
 - o margins: top 2.5 cm, bottom 2.5 cm, right 2.5 cm, left 2.5 cm.
- Times New Roman 12 pt.
- Double line spacing 2.0 (before: 0 b, after: 0 b).
- Page numbers: No.
- Line numbers: line numbering should be used throughout the manuscript.
- Manuscript range maximum 6 pages (A4), including tables and figures. Shorter papers will also be considered.

PAPER STRUCTURE

Title. Short, brief and concise information on the paper content.

Author(s). Name SURNAME

Affiliation(s). Institution name and full postal address including e-mail contact for corresponding author.

The manuscript should be divided into the following sections:

- ABSTRACT
- KEYWORDS
- INTRODUCTION
- MATERIAL AND METHODS
- RESULTS AND DISCUSSION
- CONCLUSIONS
- ACKNOWLEDGEMENTS (if applicable)
- REFERENCES.

Abstract. Please provide an abstract of 150–200 words. It should not contain any undefined abbreviations or unspecified references. The abstract should be divided into the following sections:

- Background and Aims (stating the main purposes and research question),
- Methods,
- Results (stating the main findings),
- Conclusions.

Keywords. Please provide 4–6 keywords at the end of abstract, which can be used for indexing purposes. They should start with small letters and should be different from the words mentioned in the title.

Introduction. It should afford a review of related works and information concerning the state of research of relevant issues. Related references are recommended. The introduction should not be divided into subunits. It is recommended to include references to papers from peer-reviewed periodicals only.

Material and methods. All preliminary material, experiments conducted, their extent, conditions and course should be described in detail. This section should consist of subunits describing equipment, methods, and procedures. It is necessary to provide readers with enough details of methods and equipment to enable the described procedure to be repeated. When methods are not original, adequate references are recommended. Statistical processing methods, including the software used, should also be listed.

Results and discussion. Results should be presented briefly in tables or figures. The author should confront partial results with data published by other authors. Provide enough data to give reasons for conclusions. The same information should not be given in different forms (tables, graphs, text). In the discussion, there is necessary to emphasise the importance of findings and to compare the information obtained with existing knowledge, if possible.

Conclusions. It is necessary to mention briefly the most important results presented in the paper, the key points of following research and experimental work, and recommendations for use in practice.

References. References should be listed in alphabetical order according to the surname of the first author, without numbering the individual items. Only papers cited in the text must be included in the list of references.

ABBREVIATIONS AND UNITS

Acronyms and abbreviations should be used sparingly, in which case the full name should be written out the first time it occurs in the paper, followed by the abbreviation in parentheses. It is not advisable to use any abbreviations in the paper title or in the abstract.

- The decimal marker is a point (0.5 m), while the thousand's separator is a comma (5,000).
- To express a unit of measurement, insert a thin space between the number and the unit (5 g; 20 ha).
- Use $kg \cdot m^{-3}$ instead of kg/m^3 .
- Use 'from 1990 to 1995' (not from 1990–95), or 'between 1990 and 1995' (not between 1990–95).
- Per cent. With figures, use the percentage sign (%) preceded with no thin space (25%).
- Multiplication sign. Change points used as a multiplication sign to 'x' (2.5 . 10^5 becomes 2.5×10^5).
- Degree sign. The degree sign in temperatures should be preceded by a thin space (25 °C).
- Dates. Write out the month preceded by a simple figure for the day (e.g. 25 June 2012). Use all four digits when referring to specific years (i.e. 2012 not '12). However, in tables and figures, the month may be written as a number (1. 1. 2015).

• Contractions. In research and academic writing, it is always recommended to avoid contractions (e.g. aren't, don't, isn't). Contractions are common in informal text, but not in formal texts.

FIGURES

Refer with Fig. 1, Fig. 2, etc. Figures should be presented as part of the text. The caption should be placed below the figure. Only very good photocopies are acceptable. For the best quality, pictures should have a resolution of 300 dpi. Colour figures are welcome for the online version of the journal. Generally, these figures will be reduced to black and white for the print version. Use a capital letter to refer to figures in the text (*Fig. 1*).

TABLES

Refer with Table 1, Table 2, etc. Tables should be presented as part of the text. A descriptive title should be placed above each table. Units in tables should be given in standard brackets (meV). Abbreviations or symbols used in tables must be explained as a footnote below the table. Use a capital letter to refer to tables in the text (Table 1).

EQUATIONS

Refer with Eq. (1), Eq. (2), etc. There should be one line of space above the equation and one line of space below it. Equations must be editable (equation editor in Microsoft Word). For mathematical expressions that must be embedded in text, use the equation editor only when you cannot create the expression using standard word-processing functions. For example, expressions such as 5.5×10^8 can be created in Microsoft Word using superscripting, subscripting and symbols. Equations should be aligned to the left margin and their numerical designation to the right margin.

CITATIONS AND REFERENCES

Required system for resources referencing: Harvard System of Referencing (HSR). Harvard Referencing System is known as the Author and Date system and there are two parts: the author and the date are referred to in the main text of manuscript and all of the resources referred to in the main text are included in the reference list.

References should not be numbered, but they should be arranged alphabetically.

- Citations in main text: one author or corporate author (Surname, 2017 or FAO, 2017), two authors (Surname and Surname, 2017), three and more authors (Surname et al., 2017), anonymous or official document/project name/official public or political entity (Seventh Framework Programme, 2013).
- Et al. 'et al.' stands for 'et alii'. It does not have a period after 'et' and does have one after 'al'.
